



Immunization Requirements for All Grade Levels

1. DTAP (Diphtheria, tetanus and pertussis):

- **Preschool/Pre-K: 4 or more doses are required.**
- **Kindergarten: 4 or more doses are required.**
- **1ST to 12TH: 3 or more doses are required.**
- **6th-12th grade: Tdap (tetanus, diphtheria and pertussis) vaccine.**
 - . **Student entering 6th grade shall show proof of receiving one dose of Tdap vaccine regardless of the interval since last DTaP, DT, or TD dose.**
 - . **Student entering 7th-12th who have not already received Tdap are required to receive 1 Tdap dose regardless of the interval since last DTaP, DT, or TD dose.**
 - . **If a 6th-12th grade student does not have proof of a Tdap vaccine before Oct 15th, 2019 as per state law the child will be subjected to exclusion from school unless medical or religious exemption has been approved with a physician letter.**

2. Polio:

- **Preschool/Pre-k: 3 or more doses are required (either all IPV or OPV)**
- **Kindergarten to 12th: 3 or more doses are required either all IPV or OPV.**
- **Any student who received any integration of IPV and OPV vaccine type must show proof of having received at least 4 doses with last dose on and after the 4th birthday**

3. MMR (Measles, Mumps and Rubella):

- **Preschool/Pre-K- 1ST doses are required on or after 1st birthday**
- **Kindergarten to 12th: 2 doses are required**
- **All measles, mumps and rubella cases diagnosed on or after July 1st, 2003 must be confirmed by laboratory evidence or physician diagnosed case of measles, mumps and rubella providing dates and physician certification.**

4. HEPATITIS B:

- **Preschool/Pre-K: 3 doses of hepatitis**
- **All students entering 6th-12th grade must have 3 doses of hepatitis B vaccine.**
- **The interval between 1st and 2nd dose must be no less than 4 weeks apart.**
- **The interval between 2nd and 3rd dose must be at least 8 weeks (2 month) apart.**
- **The interval between 1st and 3rd dose must be at least 4month apart (16 weeks)**

5. VARICELLA VACCINE:

- **Preschool/Pre-K: - 1ST dose is required on or after 1st birthday.**
- **Kindergarten to 12th: 2 doses are required**

- All varicella cases diagnosed on or after July 1st, 2004 must be confirmed by laboratory evidence or Physician diagnosed case of measles, mumps and rubella providing dates and physician certification.

6. Meningitis Vaccine.

- All students entering 12th grade must have 2 doses of meningococcal vaccine before Oct 15th, 2019 as per state law the child will be subjected to exclusion from school unless medical or religious exemption has been approved with a physician letter
- 6th-11th grade: One dose of meningitis vaccine is required must be given on after 10th birthday

7. Pneumococcal conjugate vaccine:

- Pre-school/Pre-K: One dose is required after age 2.

8. HIB (Haemophilus influenza Type B):

- Require 3 doses at age of 12-15 month. Children 24-59 month 1 dose is required.
- Grade: KG, 6th and 9th and all new students (including Preschool and Pre-K) Physical forms are due before 1st day of school and must have been administered within the last 10 months prior to the first day of school. As per state law the child will be subjected to exclusion from school unless a medical or religious exemption form is submitted to the school.
- Students who fail to turn in dated documentation for the required vaccination doses will need to turn in blood test result for vaccine titer values in order to meet the proof of immunity requirement.
